### Course Objectives

The Arizona Choir assembles some of the most gifted and skilled graduate and, in special cases, undergraduate singers at the University of Arizona. Participation in the ensemble helps to prepare students for participation in a range of vocal ensembles, especially professional choirs. Vocal health, artistic independence, and mature musical style are encouraged and form the foundation of the ensemble. The Arizona Choir, along with the Symphonic Choir, represents a flagship of the UA Choral Department and performs often around the community.

### Attendance & Grading

Grades are earned through a point system. The following are ways to earn points:

Rehearsal Attendance	10 points
Part Check	0–10 points

The following are ways to lose points:

No music or pencil	2 points
Tardiness*	4 points
Miss pre-concert rehearsal	all points, automatic fail
Miss concert	all points, automatic fail

\***Tardiness** is defined as a singer's unpreparedness to rehearse/perform. To avoid tardiness deductions, be in your seat, with music and pencil, prepared to sing before rehearsal starts and stay through to the end of rehearsal. Missing more than 50% of a rehearsal counts as absent.

Each time an absence or tardy is recorded for a student, they will receive a notice from the ensemble manager. This email hopes to ensure accurate and complete attendance records. Students have one week from the receipt of the email to appeal an error in the records. After that point, changes will not be made.

Final grades are calculated from the percentage of (all points earned - all points lost)/total possible points.

## **Waivers**

The Choral Department believes deeply in the importance of engaged, earnest participation during rehearsals and concerts. And, since when a singer is not present the ensemble is incomplete and rehearsal is limited, we require full participation by all singers. There are no excused or unexcused absences: *all absences are treated equally*.

In most cases of absence and tardiness, the point system automatically adjusts. Therefore, please stay in communication with the choir's manager about your attendance—we like to know where you are if you're not in rehearsal—but absences will not be excused. In certain circumstances, however, absences can be waived or tardiness penalties removed.

An **absence waiver** removes that day's possible points when calculating your average. Therefore, your grade percentage would be calculated from a smaller total possible points. The following are typical reasons to request an absence waiver: graduate school auditions, UA-related travel, professional 'gigs' of exceptional stature, illness with documentation, religious holidays, weddings, and dress rehearsal or performance for another credited UA ensemble. The following are not reasons to request an absence waiver: general illness, unexpected class conflicts, work, parking or traffic congestion, extended travel, etc.

*To request an absence waiver*, notify the ensemble manager by email within the first five days of classes—most waivable events are pre-planned and can be anticipated. In the case of illness and other unpredictable waivers, contact the ensemble manager as quickly as is safely possible. The manager will ask the professor of record to approve/deny each waiver request and notify the student of the decision.

**Tardiness waivers** are possible only in rare occasions. The most common, waivable reason for a tardy arrival is a distant, on-campus class immediately before rehearsal. The following are not reasons to request a waiver: parking or traffic congestion, other classes/lessons ending late or starting early.

*To request a tardiness penalty waiver*, notify the ensemble manager by email within the first five days of classes of problems you anticipate, or as soon as possible after an unpredicted tardiness. The manager will ask the professor of record to approve/deny each waiver request and notify the student of the decision.

## **Vocal Rest**

There are times when your vocal health and other performance obligations will necessitate you not singing during a rehearsal. Your conductor wants to support your vocal health and offers the following for those resting their voice:

- Sit within the ensemble and stay fully engaged with the others, marking your part as needed. While we still miss your vocal contributions, this approach will ensure you don't miss anything reviewed in class.
- Be certain you're supporting your vocal health by proactively making good decisions:
  - get at least seven hours of sleep at night,
  - hydrate appropriately,
  - avoid excessive talking,
  - avoid all shouting, and
  - don't visit loud places.

Any student electing vocal rest must email the ensemble's conductor, their voice teacher (if applicable), and the ensemble manager. The email must be sent before rehearsal. In the event of a multi-day rest, you may send one email.

If instances of vocal rest continually exceed 20% of rehearsal time, singers will be asked to meet privately with their conductor and teacher to discuss the student's health and ensemble participation. In cases without a clear justification and, as applicable, medical course of action, students will be asked to withdraw.

## **Apparel**

Performance attire is all black, inclusive of shoes, hose, and/or socks. Singers are encouraged to dress modestly avoiding excessive ornamentation and scents.

4. Attempting to commit an act prohibited by this Code. Any attempt to commit an act prohibited by these rules shall be subject to sanctions to the same extent as completed acts.
5. Assisting or attempting to assist another to violate this Code.
