Course Objectives

The UA Collegium Musicum (CM) is a choral ensemble that specializes in vocal works primarily from the Renaissance and Baroque periods. Students will gain hands-on experience with historical performance practices and engage with a broader cultural context of the current repertoire. As with other choral ensembles, students in the CM will also practice typical choral-vocal techniques such as diction, intonation, sight-reading, etc.

Attendance & Grading

Grades are earned through a point system. The following are ways to earn points:

Rehearsal Attendance	10 points
Part Check	0–10 points

The following are ways to lose points:

No music or pencil	2 points
Tardiness*	4 points
Miss pre-concert rehearsal	all points, automatic fail
Miss concert	all points, automatic fail

***Tardiness** is defined as a singer's unpreparedness to rehearse/perform. To avoid tardiness deductions, be in your seat, with music and pencil, prepared to sing before rehearsal starts and stay through to the end of rehearsal. Missing more than 50% of a rehearsal counts as absent.

Each time an absence or tardy is recorded for a student, they will receive a notice from the ensemble manager. This email hopes to ensure accurate and complete attendance records. Students have one week from the receipt of the email to appeal an error in the records. After that point, changes will not be made.

Final grades are calculated from the percentage of (all points earned - all points lost)/total possible points.

Waivers

The Choral Department believes deeply in the importance of engaged, earnest participation during rehearsals and concerts. And, since when a singer is not present the ensemble is incomplete and rehearsal is limited, we require full participation by all singers. There are no excused or unexcused absences: *all absences are treated equally*.

In most cases of absence and tardiness, the point system automatically adjusts. Therefore, please stay in communication with the choir's manager about your attendance—we like to know where you are if you're not in rehearsal—but absences will not be excused. In certain circumstances, however, absences can be waived or tardiness penalties removed.

An **absence waiver** removes that day's possible points when calculating your average. Therefore, your grade percentage would be calculated from a smaller total possible points. The following are typical reasons to request an absence waiver: UA-related travel, conferences or other professional invitations in your major area, UA Dean's Excuse, illness with documentation, religious holidays, weddings, and dress rehearsal or performance for another credited UA ensemble. The following are not reasons to request an absence waiver: general illness, unexpected class conflicts, work, parking or traffic congestion, extended travel, etc.

To request an absence waiver, notify the ensemble manager by email within the first five days of classes—most waivable events are pre-planned and can be anticipated. In the case of illness and other unpredictable waivers, contact the ensemble manager as quickly as is safely possible. The manager will ask the professor of record to approve/deny each waiver request and notify the student of the decision.

Tardiness waivers are possible only in rare occasions. The most common, waivable reason for a tardy arrival is a distant, on-campus class immediately before rehearsal. The following are not reasons to request a waiver: parking or traffic congestion, other classes/lessons ending late or starting early.

To request a tardiness penalty waiver, notify the ensemble manager by email within the first five days of classes of problems you anticipate, or as soon as possible after an unpredicted tardiness. The manager will ask the professor of record to approve/deny each waiver request and notify the student of the decision.

Rehearsal/Performance Presentation

Please arrive at all ensemble events—such as rehearsal and performances—without any distinguishing body odor. This is asked in deference to all singers, especially those with sensitivities to strong and/or chemical odors. Plan accordingly for long rehearsals, especially warm venues, and circumstances requiring close physical proximity. In performance, please also be aware of minimal visual distraction by hair, jewelry, shoes, etc.

In performance, unless otherwise noted, singers are expected to wear a performer's all-black outfit, inclusive of shoes, hose, and/or socks. Sleeves should be at least $\frac{3}{4}$ length, covering at least half of the forearm. Pants should be full length, with no more than a slight break, ankle never wholly visible. Skirts and dresses should be floor length.

5. Assisting or attempting to assist another to violate this Code.
